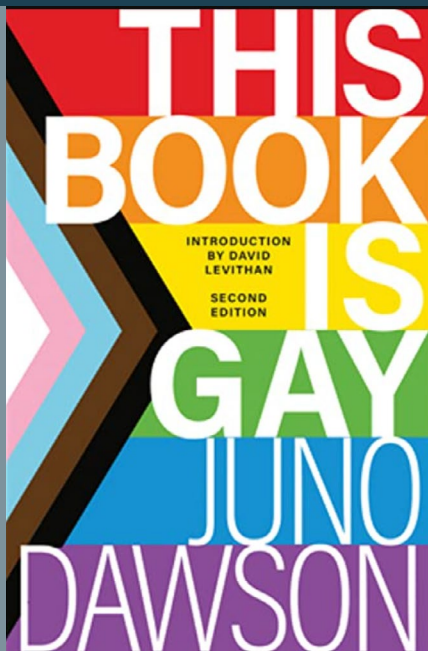

THE SUPREME COURT HAS RULED THAT

"transmitting obscenity and child pornography, whether via the Internet or other means, is... illegal under federal law for both adults and juveniles"

— *Reno v. ACLU*, 521 U.S. 844 (1998)

Obscenity is not protected under First Amendment rights to free speech, and violations of federal obscenity laws are criminal offenses. Obscenity is defined as anything that fits the criteria of the Miller test, which may include, for example, visual depictions, spoken words, or written text.

Okay...So why is it then that our K-12 system is inundated with pornography?

LEGAL ANSWER & DIE ANSWER

There is the legal answer & the DIE (Diversity, Inclusion, Equity) answer. Let's look at the legal one first.

LEGAL ANSWER

- "Obscenity Exemption Statute" (OES). Currently 43 states have this OES. This was quietly pushed by radical groups that support the teachings of pedophile [Dr. Alfred Kinsey](#); they argued that sexual material should be considered "sex education" if presented in a classroom.
- Over the years radical groups such as the ACLU, LGBTQ, Planned Parenthood, teacher's unions, American Library Association, etc. have used this OES loophole to bring in the very books that parents are fighting today.

- To put it simply, if an adult showed "[Gender Queer](#)" to a minor at a park, she would most likely be arrested for breaking the federal obscenity law. However, if she took that same child across the street, walked into a classroom, she (a "teacher") would not be arrested due to the OES.
- The only 8 states that do not have an OES are: Alaska, Arizona, Colorado, Indiana, Missouri, Oklahoma, New Jersey and Rhode Island. **Parents from those states need to leverage the obscenity law to it's fullest extent because we know pornographic books exist in their respective schools.**

BUT WAIT...OES have existed in many states since the 1960's, why are we all of a sudden seeing this influx of these books in K-12 in recent years?

Good question...this brings us to the DIE Answer

DIVERSITY, INCLUSION & EQUITY ANSWER

DIE was the marketing scheme that covered for SEL/CRT/Transgender ideology, but for the purpose of this guide, there was one thing that DIE implemented that set the foundation for pornographic books:

Each time parents protested...

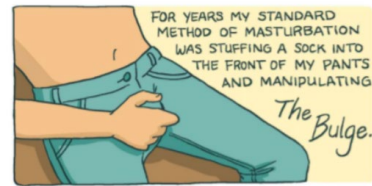
...activists & woke school administration leaned into both of those lies. Parents would then acquiesce. Rinse & repeat.

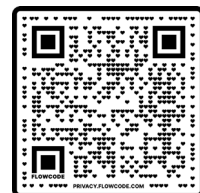

I exercise my right under the U.S. Constitution, to direct the upbringing, care, and education of my
child, and place school administrators on notice of the following:

I, the undersigned parent/guardian, DEMAND that my child BE EXEMPT from the following
activities and materials in the school library for the current academic year:

- Visiting or attending activities in the library
- Interaction with any library staff (librarians)
- Access to books and materials that explore and/or feature LGBTQ themes and gender ideology

I, the undersigned parent/guardian, DO NOT CONSENT for my child be assigned or encouraged to
participate in any library-related projects, assignments, or reading activities.

I hereby request that I be given prior notice and instruct that my child be given alternative
academic instruction during the same period that any presentation or instruction on any aspect
regarding the above is provided.

I hereby direct that this notification be placed in my child's permanent file[s] and be provided to
all people instructing, advising, or interacting in any way with my child during the school year. Any
violation of this notice will be the subject of further legal action to protect my child. This notice
and directives supersede any previous consent related to my child, and is continuing until I provide
different written directives.

I look forward to your prompt confirmation of receipt and your full compliance with the terms of
this letter.
